# Entry & Enrolment

## Step 1: Apply

The application process varies for each course. Please follow the instructions on the course information page.

**The eligibility criteria may vary for some courses so please check the criteria to ensure you are eligible.**

## Step 2: Attend for interview.

Applicants will be invited by post for interview at the centre. The first round of interviews will take place in early June and the last round of interviews will be in August if there are still places available.

## Step 3: Accept Place on Course

Successful applicants will be notified of the offer of a place on a course by post and must secure this place by accepting their place before a set date. Failure to do so may result in the place being offered to another applicant.

## Step 4: Start the Course

Students will be informed of the start date when offered a place on the course. All students must attend the centre on this date. If you cannot attend on this date please let the centre know to retain your place.

### **Please Note:**

**Admission to a particular course is subject to places being available on the course and the following criteria being satisfied:**

- Based on the applicant's previous education, training or experience, the applicant is considered likely to benefit from participation in the centre.
- Following an interview the applicant is considered suitable for the course.
- The participation of the applicant on the course will contribute positively to the course and will not disregard the rights of other students or staff.
- As work experience with children or vulnerable adults is an essential part of some course, participants on these courses are required to be Garda vetted. Continued participation on the course and work placement is dependent on the successful completion of this process.
- A minimum enrolment is required for courses to run.

**Places on courses are limited, so early application is advisable.**

## Course Description

Studying towards a childcare qualification is an enjoyable journey as you will get to explore all aspects of a child's development, from safety and psychology, to regulation and legislation.

# Gateway Programme – QQI Level 4

## QQI Courses St Colman's Community College, Midleton.

St Colman's offers a variety of QQI Level 5 and 6 Courses during day or night. Daytime courses have minimal costs and are about 20 hours per week (usually 4 mornings). Begin in September and end in May. Usual Grants and Back to Education allowances apply. Night-time awards are one night a week for two years and cost €140/€180 per component, 8 components required for an award.

## Further Education and Training

Further Education and Training (FET) is education or training for adults or young people which can lead directly to employment or offer a bridge to Higher Education, i.e. at University or an Institute of Technology. Further Education and Training is for school leavers but also mature students who left school early or who wish to improve their qualification or change their career path.

## QQI

QQI (Quality and Qualifications Ireland) is a state agency established by the Quality Assurance and Qualifications (Education and Training) Act 2012 with a board appointed by the Minister for Education and Skills. Their functions include those previously carried out by the Further Education and Training Awards Council (QQI); the Higher Education and Training Awards Council (HETAC); the Irish Universities Quality Board (IUQB) and the National Qualifications Authority of Ireland (NQA). ## Progression from QQI Awards to Higher Education Courses

Learners who achieve a full QQI level 5 award can apply through the CAO to many higher education institutions. Specific QQI level 5 awards are linked to reserved places on higher education courses.

## National Framework of Qualifications



The NFQ is a ten level system that incorporates awards made for all kinds of learning, large and small, whether it is gained in schools, the workplace, the community, training centres, colleges or universities.

For each level of the NFQ, standards of knowledge, skill and competence have been set out, defining the outcomes to be achieved by a learner seeking to gain a qualification.

School, further education (QQI awards) and higher education (DIT, university and HETAC awards) are all included.
