

**Minutes of Youghal Town Council held on 15th February 2011 at 10.00 a.m.
in The Mall House, Youghal**

Opening Prayers:

The member and officials recited the opening prayers.

Co-option of Tomás O' Conaill to Fill Vacant Labour Party Seat on Youghal Town Council:

The Mayor and Members welcomed back to the Chamber Cllr. O' Conaill whose co-option has been ratified by The Labour Party.

Minutes of Monthly Meeting held on 11th January 2011:

The minutes of the monthly meeting held on 11th January 2011 were adopted on the proposal of Cllr. Revins, seconded by Cllr. Coyne and unanimously adopted by the members.

Minutes of Budget Meeting held on 11th January 2011:

The minutes of the Budget Meeting held on 11th January 2011 were adopted on the proposal of Cllr. Coyne which was seconded by Cllr. Linehan Foley and unanimously adopted by the Members.

Report of the Town Clerk on Matters Arising from the Monthly Meeting of Youghal Town Council held on 11th January 2011.

4. EDUCATION

Youghal has a well established education infrastructure which serves the town and hinterland. Traditionally the principal service provision is located within the town. In common with many towns demand in particular for primary schools, has arisen where population has been expanding on the town's outskirts while town centre schools can be under utilised.

The Town Development Plan (2009) notes that many schools are generally located in old buildings in the town centre and that moving some of them to new facilities on the outskirts may meet increased need from these areas as the population increases. Older facilities could be refurbished for change of use.

4.1 EDUCATION PROVISION

Four primary schools principally serve the town with additional provision being made at Clonpriest NS and the smaller Kyle NS. The largest primary school, Bun Scoil Mhuire provided 506 places, with equal number of boys and girls. Gaelscoil provision is made through Gaelscoil Chorain and the South Abbey NS is a Church of Ireland school.

One Montessori school is provided in the town and five preschool child care facilities;

- Clashmore After School Service, Community Ctr Closnaomh Mochua
- Little Cherubs Montessori Play, Father Murphy Hall Old Youghal,
- Rocking Horse Creche/Pre School, Raheen rd,
- Roseville House
- Sr Enda Dineen Childminding Service

In terms of second level education Pobalscoil na Tríonóide (461 boys & 444 girls in 2010/11) opened its doors to students in September 2006. The school was founded as a result of an amalgamation of three secondary schools (Loreto Secondary School, Christian Brothers, Colaiste Eoin) in Youghal. The school places great emphasis on meeting the spiritual and education needs of every student.

There is a full time adult education centre at Adult Education Centre East Cork & Harbour Region on Golf Links Road. This facility also provides a Youthreach Centre for East Cork. Training courses are also provided at Cumann na Daoine.

4.2 EDUCATIONAL ATTAINMENT

The table below shows the highest level of educational completed of those 15 years and over, whose education has now ceased. This shows that in Youghal Town, some 21% of those whose Education has ceased, have had no formal education or have been educated up to Primary level. This figure is higher than that for other towns of similar size. The table also shows that in comparison with other towns, a lower proportion of persons in Youghal Town completed their education at third level.

Table 4.3 above shows education attainment by gender for Youghal Town. Overall a larger Proportion of males cease education at an earlier stage than females. In both cases the Largest proportion of those who cease education in Youghal do so at Upper Secondary level, which includes Technical/Vocational courses. The other significant difference is a proportion of females having completed Third Level education– over 26% - as opposed to just 22% of males.

Table 4.4 above shows the breakdown of Third Level qualifications obtained for Youghal and for other towns of similar size in the State. It shows that Youghal Town has a higher percentage of persons whose highest qualification is at the 'non-degree' level qualification than occurs in the other

similar sized towns. A higher proportion of those in Youghal Town have completed education to a post graduate degree diploma level (over 13%), and professional qualification level (over 10.%) than in the other towns. It is also evident that Youghal Town has a lower proportion of persons with a primary degree (16.2%) or post graduate degree (5.6%) than the other towns.

4.3 EDUCATIONAL ATTAINMENT & UNEMPLOYMENT

There is a recognized close correlation between education and unemployment. The table below indicates level of education attainment of unemployed persons. In Youghal Town, the proportion of those who ceased education at Upper Secondary level and are unemployed is slightly higher than national figures. However an important exception is in those who ceased education at Third level and are unemployed where in Youghal these constitute a significantly lower proportion than in the rest of the State. This is likely to reflect a tendency for younger people with higher educational attainment to move toward larger cities whether employed or not.

Town Foreman's Report:

The Town Foreman's Report on works carried out from 5th January to 10th February 2011 were brought to the attention of the members and noted. Arising from the report the following items were raised.

1. Light nos. 2 & 3 at Struthain na Saili.
2. Potholes at Knockaverry.
3. Repairs at the Signal Cabin.
4. Light at the top of the Jail Steps.
5. Update on the Diving Rocks. The Town Clerk informed the members that he was awaiting a response on same from Irish Public Bodies Mutual Insurance Ltd.
6. Road repairs at the end of Cork Hill.
7. Refurbishment of 100 Blackwater Heights.
8. Overlapping trees at Chestnut Drive.
9. Insulation at no. 2 Dr. Kennedy Place.

Cork County Council Items:

Engineers Report:

1. Ponding at Ballyvergin on the old N25 has been referred to the Estates Department as it is as a result of poor reinstatement of the road after laying of Ducts/Pipes by the Developer of this private estate. This is currently being priced by a contractor.
2. Footpath replacement at Grattan Street and New Catherine Street is nearly complete.
3. The outfall at Front Strand is checked almost every day as tides permit and is cleared of debris to improve the flow as required.
4. Potholes around the town are being filled on an ongoing basis.
5. Following consultation with the Town Clerk it is proposed to resurface sections of Quarry Road and Golf Links Road. This work is to proceed shortly.
6. All work filling potholes on the Tallow Road is complete in the Cork County Council areas. It is planned to overlay a portion of this road under the NNR programme this year.

County Council Items:

1. The Town Clerk informed the members that funding in the sum of €300,000 had been acquired from the Department of the Environment, Heritage & Local Government for the relaying of the main street and that these works were due to commence in early Autumn.
2. Condition of the road near Copperally. The Town Clerk informed the members that this item be raised under the Non National Road Grant.
3. Potholes in North Main Street. Cllr. O' Conaill asked the Engineer if there had been a change in the material used for the filling of potholes. The Engineer informed the members that there has been no perceptible change in the material used but that hot mix tarmac had been replaced with cold mix tarmac. The Engineer informed the members that he would investigate the specification of the

material.

4. Broken footpaths around town.

5. Potholes on the Tallow Road. Cllr. Hennessy asked that the Town Clerk write to Waterford County Council requesting that these potholes be repaired. The Town Clerk suggested that all political parties equally apply pressure on their respective party colleagues in Waterford to apply pressure on this matter.

6. Underground ducting in the North Main Street.

7. Condition of the Mall Lane. The Town Clerk informed the members that this item could be raised under the Non National Road Grant Allocation. The Town Clerk stated that the Mall Lane was repaved for pedestrian traffic and that all Councillors should consult with each other to decide what was intended for the lane and that they should also take serious consideration in relation to the amount of traffic accessing the lane. 8. Gullies at Claycastle.

9. Ponding on the road at Claycastle.

10. Parallel parking at North Main Street

11. Cone on road outside Clancy's Bar.

12. Lack of signage coming from McCurtainstown to Front Strand.

13. Dip in road at entrance to Tesco.

14. Connection to sewer at Tallow Street.

15. Manhole at Raheen Road. The Town Engineer informed the members that this would be filled shortly.

16. Closure of Chapel Lane. The Town Clerk informed the members that this was currently on public display and that this item would be on the agenda for the March meeting of the Council.

17. The Mayor welcomed the new footpaths on the back street.

Managers Orders:

Managers Orders nos. 1/11 to 25/11 were brought to the attention of the Council and noted.

The Mayor raised the issue of Managers Order no. 9/11 and stated that she was delighted that the tree felling was to be undertaken in the Cemetery.

Cllr. Murray raised the issue of Managers Order no 1/11 and asked could the bond be drawn down on the development at Ardan na Mara as the developer has failed to address some issues regarding some of the services including the public lighting. The Town Clerk informed the members that this estate was still in the charge of the Developer.

Cllr. Murray raised the issue of Managers Order no. 6/11 in relation to the surrender of the shop at Ardrath and asked the Town Clerk what the intentions were regarding this site. The Town Clerk informed the members that it was intended to demolish the building and have a viewing area for the Town Walls on the site.

Planning Applications:

No Planning Applications were received.

Further Information Received:

The members were informed that further information in relation to planning application nos. P58023/10 & P58014/10 were received.

Mayors Business:

1. The Mayor raised the issue of the recent successful Awards Achievements Night and thanked the Deputy Mayor Eoin Coyne and council office staff member Geraldine O'Connell for their voluntary contributions. The Mayor informed the members that another awards night would be held in June

and any nominations would be welcomed. 2. The Mayor informed the members that the 25th Anniversary of the Youghal/Lamor Plage Twinning would be celebrated in June and that if any of the Members were interested in travelling to France should contact the Town Clerk.

3. The Mayor circulated photographs and a petition from the residents of Gallagher's Mews in relation to the issue of illegal dumping at the recycling site at Tesco. The Town Clerk informed the members that this was a private site. Cllr. Coyne stated that as a resident of this area he would be willing to co-ordinate a Council-Tesco residents solution to the problem.

4. The Mayor informed the members that she recently attended the Senior Citizens Dinner Dance and the Boxing Tournament in the Walter Raleigh Hotel and stated that both nights had been a great success and congratulated all involved.

5. The Mayor requested that a metal grill which had lifted on the path near the Bank of Ireland be repaired. The Engineer agreed to investigate same.

6. The Mayor read a letter received from the Youghal Community Bus Group seeking funding towards running costs. The Town Clerk informed the members that there was no funding available at present but that this item could be referred to the Budget Meeting for 2012.

2011 Regional & Local Roads Grant Allocations- Department of Transport:

The Town Clerk circulated to the members circular RLR 1/2011 from the Department of Transport in relation to the 2011 Regional and Local Roads Grant Allocations and informed the members that the total allocation was €195,000. The Town Clerk informed the Members that €26,500 had been spent of Salting and emergency repairs and an additional €25,000 spent on patching works in January, a further €80,000 on repair works to both the Quarry Road and the Golf Links Road which leaves a balance of €63,500. Cllr. O' Conaill raised the issue of the Mall Lane and suggested that the lane be closed and resurfaced for pedestrian use only. The Town Clerk informed the members that that signage costs and road design costs in relation to the Traffic Management Plan for Emmet Place/DeValera Street would need to be allocated from the balance also.

A brief discussion in relation to the Traffic Management Plan for Emmet Place/DeValera street ensued. The members agreed that a deputation of the residents be requested to attend the March Meeting of the Council and that a final decision on the plan be drawn up at the April Meeting.

Cllr. O' Conaill raised the issue of the condition of the road at the northern end of Allins Quay to the Double Slips and requested that funding be made available for this section of roadway. The Town Clerk suggested to the members that €30,000 be allocated towards the resurfacing of the Mall Lane, €15,000 be allocated for the road design and signage for the Traffic Management Plan for Emmet Place/DeValera Street and the remainder be allocated for the roadway at Allins Quay. The Town Clerk stated that the works at Allins Quay would have to be measured, quantified and a costing acquired. The members unanimously agreed to these allocations on the proposal of Cllr. Coyne seconded by Cllr. Beecher.

Guidelines for the Management & Development of Architectural Conservation Area – Cork County Council:

The Town Clerk circulated to the Members the Guidelines for the Management & Development of Architectural Conservation Area – Cork County Council and informed the members that these guidelines have been adopted by Cork County Council.

Group Personal Accident Insurance – Scheme A – Elected Members (IPBMI):

The Town Clerk circulated to the Members Scheme A of the Group Personal Accident Insurance for the elected members from Irish Public Bodies Mutual Insurance Ltd and recommended that the members proceed with this scheme.

On the proposal of Cllr. McLellan which was seconded by Cllr. Revins the members unanimously

agreed to proceed with Scheme A as in previous years.

Irish Walled Towns Network; A Review of Activities 2006 – 2010 And a 3 Year Action Plan for 2011 – 2013:

The Town Clerk circulated to the Members The Irish Walled Towns Network; A Review of Activities 2006 - 2010 and a 3 Year Action Plan for 2011 – 2013. This plan was adopted on the proposal of Cllr. Burke, seconded by Cllr. Linehan Foley and unanimously agreed by the members. The members stated that this plan proved to be very beneficial towards funding of the Town Walls and the Heritage Core of the town.

Cllr. Burke paid tribute to the Town Clerk on playing a huge part in gaining funding towards this plan.

The Members unanimously agreed to the allocation of €2,000 to the various Sporting Groups on the proposal of Cllr. Linehan Foley which was seconded by Cllr. Burke.

Taking in Charge Procedure for Gort Aoibhinn, Upper Cork Hill, Youghal:

The Town Clerk circulated to the Members public notice, map and motion declaring: "That the Gort Aoibhinn, Upper Cork Hill, Youghal, road of linear length 209 metres be declared a public road, due consideration being given to the financial implications of same".

On the proposal of Cllr. Burke which was seconded by Cllr. Beecher the members unanimously agreed to take in charge the road at Gort Aoibhinn, Upper Cork Hill, Youghal, linear length 209 metres.

Motion in the Name of Cllr. McLellan seconded By Cllr. Hennessy:

"Calling on Youghal Town Council to take responsibility for all plumbing and electrical works in all their Local Authority Houses and to review and update the tenancy handbook reflecting same".

The Town Clerk circulated to the members a report regarding this motion, a copy of which is attached to the minutes requesting that the motion be withdrawn on budgetary issues.

The Members agreed to withdraw the motion on the ground that the following section be added to the Council's Tenant hand Book in relation to Hardship Grounds;

"The Council considers request to execute "tenant responsibility repairs" where exceptional circumstances, such as old age, infirmity or disability make it impossible for the tenant to do so. If you are an old age pensioner and you are unable to look after your house, you should contact the Housing Section for more information and assistance".

This was unanimously adopted by the Members. Cllrs. McLellan and Hennessey stated that they may re-introduce the motion having considered the financial implications of same at some time in the future.
