1. <u>Confirmation of Minutes of Meeting of East Cork Municipal District held on 4th September 2023.</u>

The Minutes of the Meeting of East Cork Municipal District held on 4th September 2023 were unanimously adopted on the proposal of Cllr Hegarty and seconded by Cllr Healy.

2. <u>Matters Arising from Minutes.</u>

No matters arose.

3. Consideration of Reports and Recommendations.

3.1 Deputation from Midleton A.C.

Catherine Carroll, Member of Ceasc gave the following presentation to the Members

Our Inspiration & Why We Have Formed:

We are an extremely committed group of volunteers who are deeply invested in athletics, who have come together under the name of CEASC. To identify and secure a site in the East Cork region to develop an inclusive IWAA Athletics Track & Field facility and clubhouse within or adjacent to a Regional Park to service the entire population of East Cork.

Many of us have had the privilege to compete at the highest level & represent our country and coaching athletics is our passion. It is thanks to the young athletes we coach and our vision for their futures & that of the wider community that this presentation is brought before you today.

Thanks to our meeting with all the councillors last July, the support of everyone here today and David Stanton TD and work by other active groups, our efforts have focused on the Northern Relief Road site as the prime location for this inclusive and sustainable development.

The project concept was initiated in 2017 at club committee level by Midleton Athletic Club & developed into a wider community based development group, with both groups consulting with public and Cork County Council and local landowners.

All parties involved from 2017 to date will now be working together on this project going forward which we are very pleased about as it acknowledges all the hard work completed and broadens our skillset for our group which is ever growing. Competitive events take the athletics community the length and breadth of the country.

It has exposed us to the highest standard of athletic facilities situated beside Regional parks where park runs can be held alongside picnic spaces, safe walking routes, playgrounds, freely accessible basketball courts and tennis courts, outdoor gyms.

Many clubs in the Region do not own their own grounds to develop facilities and are renting grounds from other organisations and are reliant on these arrangements to stay in place to avoid a situation where clubs have to close, unable to meet the needs of their members.

Many clubs are struggling to provide space for younger athletes joining yet paradoxically are also struggling to retain teenage athletes again due to inadequate facilities for meaningful athletic development.

Exposure to Diamond League meets throughout the year along with TV coverage of European, World Championships and the Olympics across all levels of ability has made track athletics very appealing to younger audiences and we have a host of talent coming through with potential for many more.

Athletics Tracks can be and should be <u>inclusive</u> for all users when **accessibility** is central in the design process where all needs for younger, older, physically and intellectually disabled members are considered.

This will provide safe enclosed spaces for those in particular with additional needs can participate, enjoy, relax and just BE.

There really is nothing better than a visual to demonstrate how the Region of East Cork is lacking Athletic Track and Field facilities, depicted in the map opposite.

There are tracks being developed all over Munster

East Cork not there YET!

This project will deliver a community hub for clubs to come together and train in a top spec facility and make athletics a fully inclusive sport in the area.

If the years of covid restrictions, fear and lockdowns have taught us anything, it is that social interaction and physical activity are essential human needs.

East Cork needs this facility. The population of East Cork is exploding facilitated by vast housing developments throughout the region, yet our sporting facilities and social spaces particularly for young people and families are sparse. Healthy social dynamics and amenities are so imperative and interlinked.

What we want for our community;

Athletics track to adhere to International World Athletics standard (8 lane 400m).

Track surface to be one colour, requested by special Olympics (bi coloured tracks have found to be more confusing for athletes with intellectual disabilities.

Steeplechase/ water jump

Floodlighting for track facilities

Fencing and CCTV for safety and security

Wheelchair accessible amenities throughout the facility incl the track perimeter

Field sports such as shot putt, discuss, hammer, javelin, long jump, high jump and pole vault.

Throwing cage x 1 and grass inner area for landing

Spectator viewing perimeter- large enough to pitch club tents and picnic blankets.

Clubhouse with hall, kitchen, storage area, admin area for electronic timing and photo finish viewing (must be located at the finish line).

Car, bus and bicycle parking

Toilet, shower and changing facilities Including wheelchair bed changing facilities.

Utility Substation

The Site

CEASC are asking for 20 acres of council land to develop T&F Facility a club house and parking for buses, cars and bicycles.

Track Orientation: Need to take into account potential need for rotation of the track after completed surveys in particular ground levels, topological, lighting and traffic impact reports.

The Site:

A Regional Park for Cork East

We are inspired by Limerick City, County Council and Fingal Council's embracing, development and funding of the Limerick Regional Athletics Hub and Fingal Athletics track.

The site is suitable on flat ground outside of flood plains, it is ideally situated for connectivity to local transport, walkways, schools & houses.

The visibility of the site on the relief road will add to the appeal and safety of the facility

We are proposing that the area marked in green be the locations for the track and clubhouse.

The area in blue which is a floodplain, which in our view is a suitable location for the creation of a purpose built hill course using the topsoil from ground works in other parts of the development.

Connecting this part of the development to the linear park with foot bridges similar to those used in Ballincollig Regional Park would bring an array of running/walking route options for hosting club training venues, a parkrun for East Cork, Relay for Life and Fit4Life events.

Hosting events such as these are key to delivering a facility that is sustainable for generations to come.

3.2 Taking in Charge – Ashdale, Cloyne.

Mr. Joe McCarthy, Municipal District Officer circulated the following email received from Liam Murphy, Estates Section in relation to the taking in charge of Ashdale, Cloyne, Co. Cork.

The Council gave notice of its intention to consider the making of an order under Section 11 of the Roads Act, 1993, to declare the road in the developed area described above to be public. This Notice appeared on the Examiner newspaper on Friday 27th January 2023.

- The Public Consultation period expired 6 weeks thereafter. No submissions were received.
- The process intended is to declare the Estate Road to be a Public Road under Section 11(i)(e) of the Roads Act 1993. Where a Road is thus Taken in Charge the Council will by virtue of Section 180(4) of the Planning and Development Act 2000 as amended, also as a consequence Take in Charge any Open Space, Car Parks, Public Lighting, Sewers, Watermains or Drains within the attendant grounds of the development. The attached layout outlines the areas what will be Taken in Charge, subject to the road being declared public.
- Sewers, watermains or drains within the attendant grounds of the development are now a
 matter for the Water Authority, i.e., Irish Water. In this regard, Irish Water has confirmed
 that they have no objection to the estate being Taken in Charge and that they will assume
 responsibility for Sanitary Services (i.e., foul sewer and watermain) after the estate is
 formally Taken in Charge. Subject and subsequent to the road being declared public, these
 assets will be transferred to Irish Water by Ministerial Order pursuant to Section 7 of the
 Water Services (No. 2) Act 2013.

"That being satisfied that a public right of way exists over it, and the road is of general public utility, Cork County Council hereby declares pursuant to Section 11(1) of the Roads Act, 1993 the following road to be a public road":-

Cllr. McCarthy asked if there was any update on a commencement date for the works at Riverside Estate. Mr. Dave Clarke, Senior Executive Engineer informed the Members that he is working with the contractor to get a revised date for the commencement of these works.

Cllr. Hegarty raised the issue of works at the Upper Range Road at Rostellan and asked if works could be undertaken on the section of old road near the GAA grounds. Mr. Dave Clarke, Senior Executive Engineer informed the Members that drainage works will be completed this year which should largely address problems at this location.

Cllr. Linehan Foley asked if there was any update on works for the Belmont Road. Mr. Dave Clarke, Senior Executive Engineer informed the Members that the design works will be complete this week and the tender has been awarded with works being completed by the end of this year.

Cllr. Healy asked if there was any possibility of works taking place on the 2nd half of the road from Tops Cross to Ballincurrig. Mr. Dave Clarke, Senior Executive Engineer informed the Members that he will be applying once again this year for funding for works at this location under the Climate Adaptation Grant Scheme.

4. <u>Business Prescribed by Statute.</u>

None.

5. Notices of Motion.

5.1.1 Cllr. Susan McCarthy received on 14th August 2023

"Due to the serious lack of amenity in the East Cork area, I am calling on my colleagues to support me in putting a call to full Council to secure land as a potential site for a sports centre in Midleton. The priority of this sports centre is to provide a running track, with the potential for all weather pitches, courts and the possibility of other amenities such as a swimming pool into the future. With such low availability of council land, and from a previously commissioned Feasibility study supported by members of this municipal district, we are aware that this proposal may necessitate use of proposed residential land. We believe this may be the only option as provision of such amenity is so critical in a high density population area. It is widely accepted that such facilities reap both physical and mental health benefits within communities, and we are willing to take the steps necessary to ensure access for all to such amenities into the future".

Cllrs. Ahern, Hegarty & Linehan Foley supported this motion.

Cllr. Ahern asked if Cllr. McCarthy withdraw the possibility of the swimming pool amenity from the motion and put forward the provision of a sports centre only. Cllr. McCarthy stated that she was in full agreement with Cllr. Ahern's proposal.

5.1.2 Cllr. Susan McCarthy received on 26th September 2023

"That a road safety audit be carried out at Ladysbridge to improve safety for all road users to include pedestrians, cyclists and those with reduced mobility. As five roads meet here it is vital that drivers have more awareness of right of way and that pedestrians have safe crossing points".

Cllrs. Hegarty, Ahern, Linehan Foley & Quaide supported the motion.

Cllr. Hegarty stated that Ladybridge village has grown substantially in the past with the need for consideration of a pedestrian crossing and speed ramps on both sides of the road at the Monument to the Thatch and also on the Ballymacoda Road.

Mr. Dave Clarke, Senior Executive Engineer informed the Members that Cork County Council's Road Safety Officer has undertaken an inspection and will prepare a report on the issues raised which will be circulated to the Members once available.

5.1.3 Cllr. Susan McCarthy received on 26th September 2023

"Seeking an update on works to be carried out at steps from Dungourney Road /Clonmult Tce to Suncourt Estate. As mentioned previously this is a passageway commonly used not just by elderly residents, but also school children to get to the northern end of town".

Mr. Dave Clarke, Senior Executive Engineer informed the Members that the existing steps are either concrete or stone masonry, the stone is red limestone or Midleton Marble, the Engineer stated that the existing steps are irregular in height and length and the red limestone has a poor grip, therefore warranting the replacement of the steps. Following consultation with the County Archaeologist it is proposed to salvage and retain Midleton Marble Masonry for reuse in a future public realm project in Midleton Town and reconstruct the steps in concrete. Rebuilding the steps with the existing stone masonry would not be appropriate and the proposed works will be completed before the end of the year.

5.1.4 Cllr. Ann Marie Ahern, received on 19th September 2023

"That this MD write to Bus Eireann to seek the installation of a proper bus stop and shelter at Mogeely Village".

Cllrs. McCarthy & Hegarty fully supported this motion and requested that they attend a meeting of the East Cork Municipal District as soon as possible.

5.1.5 Cllr. Ann Marie Ahern, received on 19th September 2023

"Is there any update on the speed review or installation of safety measures on the Mogeely to Killeagh Road".

Cllr. Hegarty supported this motion.

Mr. Dave Clarke, Senior Executive Engineer informed the Members that a traffic count and speed survey was carried out by Council Staff over a 24 hour period from 31st July to 1st August. A traffic and speed radar was located approximately 100 metres on the Killeagh side of the playground entrance. A total of 2018 vehicles were recorded during the survey period. An average speed of 51 kph was recorded and an 85%ile speed of 62 kph was recorded. The results of the survey demonstrate that a significant number of drivers are driving in excess of the posted 50 kph speed limit in what is clearly a built up area. The Engineer stated that this road will be considered for further traffic calming measures in accordance with the Council's Policy for Traffic Calming in Towns and Villages.

5.1.6 Cllr. Ann Marie Ahern, received on 19th September 2023

"If a schedule of clearing of drains can commence due to the autumnal weather and drains being blocked".

Mr. Dave Clarke, Senior Executive Engineer informed the Members that while routine drainage maintenance takes place throughout the year, resources are prioritised to this area in the October/November period following completion of the roads programme.

5.1.7 Cllr. Mary Linehan Foley, received on 25th September 2023

"Update on Footpath for Quarry Road Youghal aware a survey was carried out in May 2023".

Mr. Dave Clarke, Senior Executive Engineer informed the Members that no update has been received from the Traffic and Transportation Section to date and suggested Cllr. Linehan Foley make contact with either James Rigney Senior Executive Engineer or Cormac O' Súilleabháin, Senior Engineer, Traffic and Transportation Section on this matter.

5.1.8 Cllr. Mary Linehan Foley, received on 25th September 2023

"Any update on progress with Derelict Sites on Main Street Youghal/Castlemartyr Main Streets".

Cllrs. Hegarty, Ahern and McCarthy supported this motion.

Cllr. McCarthy requested that Midleton also be added.

Ms. Helen Mulcahy, Senior Staff Officer informed the Members that both herself and Selphan O' Callaghan, Senior Executive Officer have engaged with some of the owners of properties on South Main Street, Youghal and have made a lot of progress, there are two properties on North Main street owned by absentee landlords who are very difficult to track down.

Cllr. Linehan Foley stated that there was one property on North Main Street, Youghal near Cork Hill which is particularly unsightly and asked if there was any procedure in dealing with relevant banks on these derelict sites.

Cllr. Ahern asked if derelict properties could be acquired through compulsory land acquisition on behalf of Cork County Council.

Ms. Helen Mulcahy, Senior Staff Officer informed the Members that the whole case can be very complicated as a lot of mortgages and properties have been sold onto vultures funds or tied up in probate, the Senior Staff Officer also informed the Members that they have engaged with two property owners in Midleton in the hope of a resolution.

Cllr. Linehan Foley thanked the Senior Staff Officer and asked that this item be kept on the Agenda.

5.1.9 Cllr. Mary Linehan Foley, received on 25th September 2023

"Update on Ashe Street, Youghal".

Mr. Dave Clarke, Senior Executive Engineer informed the Members that the works at the vicinity of Taylor's Lane have been successfully tendered and the contract has been awarded, a Road Closure is being applied for and the works should commence mid November.

5.1.10 Cllr. Liam Quaide, received on 26th September 2023

"That the East Cork MD would improve pedestrian and disability access in Ladysbridge by repairing and aligning footpaths and providing a pedestrian crossing on the Main St".

This motion was dealt with under motion no. 5.1.2.

5.1.11 Cllr. Liam Quaide, received on 26th September 2023

"That the East Cork MD would set aside an area of ground of similar size and prominence in Midleton for the cultivation of a flower-bed as the site of the magnificent flower-bed on Broderick St. that was removed by the town cycle-way project".

Mr. Joe McCarthy, Municipal District Officer gave the following reply to this motion:

Your interest in Midleton's Pollinator Plan is encouraging. I fully agree that the pollinator and diversity supporting planted bed on Broderick Street was indeed very rich and colorful and I would prefer that it could remain. Unfortunately the Government supported Ballinacurra to Midleton Cycleway and Pedestrian Walkway provided for a cycleway along Broderick Street which required the removal of the existing planted bed. However a smaller planted bed will be provided at the junction of Broderick Street and Riverside Way and other work under the same scheme has resulted in pollinator and biodiversity supporting landscaping and planting schemes along the routes, for example on Dwyer's Road on the Bailick Car Park- Pontoon-Gaelscoil section of the Ballinacurra to Midleton Cycleway and Pedestrian Walkway, another element will be a significant planted bed in nearby Kennedy Park and for planting of fruit bushes to form hedging around the relocated Fallen Horse and Rider sculpture with seating also provided. This scheme also saw additional tree planting in the Riverside Park open space, the provision of a set back to facilitate easier disabled access to the Kindred Spirits Choctaw Monument and safety measures for pedestrians under the N25 overpass on the Bailick Road. There are similar planted beds at The Rock, the Baby's Walk Park and just up from the Courthouse, as well as in the Bailick Road car park. We also have plans for further pollinator and biodiversity supporting planting schemes at other locations, the latest being the Roxborough Garden on Distillery Walk road, and, incidentally, we have asked that the plants removed from Broderick Street will be used as part of the new planting schemes near the Courthouse and in the little park surrounding the Boy and Geese sculpture on the Hospital Road, Fair Green. With the very dry spell these may be under stress but we will hope for the best and replace any that do not survive.

5.1.12 Cllr. John Healy, received on 26th September 2023

"Cllr. John Healy calls on the Council to carry out urgent repair works to the Ballykilty Road".

Cllr. Hegarty supported this motion.

Mr. Dave Clarke, Senior Executive Engineer informed the Members that he will have this road inspected and listed for repairs.

5.1.13 Cllr. John Healy, received on 26th September 2023

"Cllr. John Healy calls on the Council to provide a footpath from the Killeagh GAA Pitch to the Main Street".

Cllrs. Hegarty, McCarthy & Ahern supported this motion.

5.1.14 Cllr. John Healy, received on 26th September 2023

"Cllr. John Healy calls on the Council to carry out safety improvements at the Mogeely Junction with the N25".

Mr. Dave Clarke, Senior Executive Engineer informed the Members that the request for a slip road off the N25 onto the Mogeely Road at Two Mile Inn will be referred to the NRDO.

5.1.15 Cllr. Michael Hegarty, received on 27th September 2023

"That Ladysbridge Village and surrounding areas issues be resolved – poorly designed, inaccessible footpaths for pedestrians, buggies and wheelchair users".

Dealt with under Motion 5.1.2

5.1.16 Cllr. Michael Hegarty, received on 27th September 2023

"That traffic calming measures be put in place and a pedestrian crossing and a risk assessment and road safety audit be carried out urgently".

5.1.17 Cllr. Michael Hegarty, received on 27th September 2023

"That the slipway at Ballybrannigan be repaired".

Cllr. McCarthy supported this motion.

6). Correspondence.

No correspondence was received.

7). Any Other Business.

- 1. Cllr. Linehan Foley stated that she had been contacted by a few people on the removal of the toilets at the new boardwalk and asked if any funding could be allocated for the use of two toilets for the winter period. Helen Mulcahy, Senior Staff Officer informed the Members that additional toilet facilities were brought in for the summer period and any proposed extension of these facilities would require additional central funding. Cllr. Linehan Foley agreed to follow up on the extension of this programme all year round. Cllrs. McCarthy and Hegarty supported this motion.
- 2. Cllr. McCarthy stated that all elected Members representing the people of East Cork are entitled to question any deputation in relation to their presentation.
- 3. Cllr. McCarthy asked whether trees in Westbrook Court could be attended to by the Council. Mr Dave Clarke, Senior Executive Engineer, advised that no budget had been provided to the East Cork Municipal District such work and this was confirmed by the Municipal District Officer.
- 4. Cllr. Hegarty stated that he had been contacted by residents of Yellowford, Ballymacoda and stated that resurfacing works are needed at this location due to dangerous potholes on the road.
- 5. Cllr. Healy raised the issue of a number of council tenants who have experienced leaks at The Meadows, Tir Cluain. Cllr. Hegarty supported this matter. Mr. Dave Clarke, Senior Executive Engineer informed the Members that this is a matter for the Housing Department.
- 6. Cllr. Hegarty raised the issue of several main water breaks in the Ballymacoda area recently and stated a fibre optic cable has also been damaged. Mr. Dave Clarke, Senior Executive Engineer informed the Members that the Roads Directorate are engaging with Uisce Eireann regarding a number of areas for pipe laying and stated that there is an issue of outstanding monies due to Cork County Council from Uisce Eireann which they are trying to resolve.
- 7. Cllr. Hegarty raised the issue of a drain at Glenageare West which needs to be looked at after recent extensive rainfall. Mr. Dave Clarke, Senior Executive Engineer will inspect same.

The next meeting of the East Cork Municipal District will take place on Monday 6th November at 10.30 a.m. at Mall House, Youghal.
